Participatory Asset Map

OVERVIEW AND PURPOSE METHODS

Improved access to mental health and addictions services and reduction in wait-times for children and youth is considered a key priority for the Nova Scotia Department of Health and Wellness.

It was determined that an asset map would be a useful tool to outline and organize information on eMental Health programs, tools, resources and services currently available in Nova Scotia.

eMental Health refers to mental health services and information delivered or enhanced through the internet and related technologies, such as apps, video conferencing and text.

As a result of this interest, this topic was identified as a provincial health priority for discussion at the Maritime SPOR SUPPORT Unit (MSSU) Bridge event in June 2018. A team of decision-makers, clinicians, researchers, and patient advisors was formed, and supported by the MSSU to carry out this work.

ASSET MAP PROCESS

A collaborative approach was taken that included input from team members to determine the parameters of the asset mapping. The asset map development process included:

- · Defining the purpose
- Identifying assets
- Defining criteria
- · Determining process for gathering information

DATA COLLECTION

Types of eMental Health assets were defined through team member input, and website review. Information about the assets were extracted from websites, or by email and/or telephone correspondence with organizations, when possible.

Information on eMental Health assets was collected between March 2019 and June 2019.
